**Course Description (GaDOE):** The Biology curriculum is designed to continue student investigations of the life sciences that began in grades K-8 and provide students the necessary skills to be proficient in biology. This curriculum includes more abstract concepts such as the interdependence of organisms, the relationship of matter, energy, and organization in living systems, the behavior of organisms, and biological evolution. Students will investigate biological concepts through experience in laboratories and field work using the processes of inquiry. Other topics and instructional methods specific to preparing students for the rigors of future honors science courses, Advanced Placement, and IB science courses are also included.

**Required Assignments:Required Assignments:** This class will have a variety of project-based learning, argument driven research and summative assessments. Be prepared to WORK IN GROUPS and INDIVIDUALLY on a variety of assignments. Literacy is an extremely important aspect of this class, so keep up on any required reading. Units to be covered include:

**1. Intro to Biology 2. Atoms, properties of water and acids and bases 3. Biochemistry 4. Cell structure and cellular transport 5. Energetics, enzymes, cellular respiration and photosynthesis 6. Cellular Reproduction 7. DNA and processes 8. Genetics and biotechnology 9. Evolution 10. Ecology**

**Required Materials:** 3 ring binder dedicated to biology, and colored pens/pencils/highlighters.

**Availability for Extra Help:**Primarily during instructional flex, or before school beginning at 8 am on Tuesdays and Thursdays..

**Makeup Work:** *Make up work is defined as work assigned during a student's absence, not work assigned prior to an absence. The student has five (5) school days upon returning to school to complete make-up work. The teacher has the discretion to grant a longer period to make up work if there are extenuating circumstances.*

### **Grading Calculations:**
