Students who are illegally enrolled shall be immediately withdrawn. Violations of this policy may be pursued in court.

In cases of separation or divorce, the student will be deemed to reside with the parent/guardian who is indicated in the legal agreement or the court's final decree to have physical custody. In cases of joint physical custody by parents, the student will be deemed to reside with the parent/guardian with whom the student resides overnight during the majority of the school week.
