BOE Policy JBAA:

The property address given must be the actual location where the student and parent/guardian live full time. A parent/guardian who owns property in the county, but does not reside in the county, is not considered a resident for purposes of this policy. A family that rents a home in Forsyth County, while owning a home in another county or in a different school attendance zone within Forsyth County, solely for the purpose of proving residence for their children to attend school in Forsyth County or in a different school attendance zone will be considered in violation of this policy. Students who are illegally enrolled shall be immediately withdrawn. Violations of this policy may be pursued in court.

In cases of separation or divorce, the student will be deemed to reside with the parent/guardian who is indicated in the legal agreement or the court's final decree to have physical custody. In cases of joint physical custody by parents, the student will be deemed to reside with the parent/guardian with whom the student resides overnight during the majority of the school week.
